Statement on Archival Language:

The David Allan Hubbard Library aims to describe archival materials in a way that is respectful to all communities who use, create, and are represented in our collections. However, the nature of historical materials is such that some material may represent positions, language, values, and stereotypes that are not consistent with the current values and practices at Fuller Theological Seminary.

Within our finding aids, it is possible users may encounter language that is offensive or harmful. While some language included in finding aids was written by staff, other language originates from the people and organizations that created the material. For example, folder titles are often preserved from the creators. It is standard practice not to change them and, in some cases, it provides important context about the materials. When we find problematic language created by archivists and staff we strive to update it. When we find problematic language from the original creator we will transcribe as is to preserve the context of its creation.

Administrative History

Particularly noteworthy in the beginning of the Wesleyan Theological Society were a series of conferences in the early 1960s conducted at Wesleyan/Holiness colleges under the leadership of Kenneth Geiger, president of the National Holiness Association (NHA). Important papers from these conferences were published as *Insights into Holiness* (1963) and *Further Insights into Holiness* (1963). These conferences culminated in the Winona Lake Study Conference on the Distinctives of Arminian-Wesleyan Theology, held in November 1964, and sponsored by the NHA. Papers from this conference were published as *The Word and the Doctrine* in 1965. This meeting set the stage for the organization of the Wesleyan Theological Society at the April 1965, NHA meeting in Detroit.

In November 1965, the organization's inaugural meeting at Spring Arbor College drew approximately sixty people. Reflecting the diversity of its parent body, the NHA, papers were presented by members of the Methodist Church, Church of the Nazarene, United Missionary Church, Free Methodist Church, Wesleyan Methodist Church, and the Salvation Army. When the initial membership drive ended in January 1966, the organization could claim ninety-two charter members. Since its inception, the WTS has experienced steady membership growth with 286 members by 1970. In 2005, there were 600 members from around the world.

Among the numerous ecumenical endeavors have been joint meetings with the Society for Pentecostal Studies (SPS). SPS hosted the first joint meeting at the Church of God Theological Seminary in Cleveland, TN, in 1998. Building on the success of that meeting, a second joint WTS-SPS meeting hosted by the Wesleyan/Holiness Studies Center of Asbury Theological Seminary Meeting occurred in 2003. A third joint meeting was held in 2008.

Scope and Content

This collection includes 16 linear feet of correspondence, organizational documents, minutes, membership records, audio tapes, microfilm, and conference papers. Also included is a full run of *Wesleyan Theological Journal*.
