Statement on Archival Language:

The David Allan Hubbard Library aims to describe archival materials in a way that is respectful to all communities who use, create, and are represented in our collections. However, the nature of historical materials is such that some material may represent positions, language, values, and

stereotypes that are not consistent with the current values and practices at Fuller Theological Seminary.

Within our finding aids, it is possible users may encounter language that is offensive or harmful. While some language included in finding aids was written by staff, other language originates from the people and organizations that created the material. For example, folder titles are often preserved from the creators. It is standard practice not to change them and, in some cases, it provides important context about the materials. When we find problematic language created by archivists and staff we strive to update it. When we find problematic language from the original creator we will transcribe as is to preserve the context of its creation.

Administrative History

The Worldwide Church of God (WCG), with headquarters in Pasadena, California, was officially begun in Oregon in 1934 by Herbert W. Armstrong (1892-1986). The WCG's original name was "The Radio Church of God" but changed its name to Worldwide Church of God in 1968. In 2009, WCG's name changed to Grace Communion International. The church is headquartered in Glendora, CA. and is a member of the National Association of Evangelicals.

In 1978, Garner Ted Armstrong, son of the founder, was "disfellowshipped" and moved to Tyler, Texas, where he founded a splinter group, the Church of God International. Just prior to H.W. Armstrong's death, Joseph W Tkach, Sr. assumed the title of "Pastor General" of the WCG. Tkach died in September 1995, at the age of 68 and was succeeded by his son, Joseph Tkach Jr.

From the late 1970s, WCG members raised multiple concerns regarding doctrinal issues. In the 1990s, some members sought pastoral training at Fuller Theological Seminary. Collection donor, Brenda Denzler, was a Worldwide Church of God member, who was among those who began to question the WCG's doctrine and leadership. The additional education and 1986 leadership change led to WCG's transition in doctrinal issues. Since 1986, observers of WCG affairs can list up to 40 changes in doctrine, as well as a withdrawal from circulation of a number of Armstrong's written works. One example was the issuance of a new statement of faith giving greater authority given to Biblical teachings than previously recognized.

Scope and Content

The collection includes materials related to Denzler and other Worldwide Church of God members who questioned the church's leadership and doctrine. Dates range from the late 1970s - 2008. Contents include financial records, written histories, church newsletters, audiovisual materials, and correspondence.

The collection does not include material related to the WCG's affiliated Ambassador College (1947-1997)'s administration, class materials, or yearbooks. The collection does include copies of the newsletter "The Ambassador Report."
