Institutional Record Retention. Materials were gathered from the files of President David Allan Hubbard and the Provost. Doris Wagner also gifted a binder to Dr. Richard Mouw, which was transferred to the Legal Department for safe-keeping. The materials were stored in banker's boxes in the basement of Slessor Hall. They were incorporated numerically with a large number of additional boxes of records from the FTS Legal Department. In 2017-2018, the Legal Department sorted through the boxes of materials. Boxes 18 and 19 (which included the binder from Doris Wagner) were transferred to the FTS Archives and processed.

#### Statement on Archival Language:

The David Allan Hubbard Library aims to describe archival materials in a way that is respectful to all communities who use, create, and are represented in our collections. However, the nature of historical materials is such that some material may represent positions, language, values, and stereotypes that are not consistent with the current values and practices at Fuller Theological Seminary.

Within our finding aids, it is possible users may encounter language that is offensive or harmful. While some language included in finding aids was written by staff, other language originates from the people and organizations that created the material. For example, folder titles are often preserved from the creators. It is standard practice not to change them and, in some cases, it provides important context about the materials. When we find problematic language created by archivists and staff we strive to update it. When we find problematic language from the original creator we will transcribe as is to preserve the context of its creation.

#### **Administrative History**

The Charles E. Fuller Institute of Evangelism and Church Growth was a joint venture of Fuller Theological Seminary and the Fuller Evangelistic Association (FEA) from June 6, 1980 to June 13, 1992. The program sought to combine the interests and skills of both organizations to provide educational resources for ministers world-wide using the most up-to-date technology. Key participants included David Allan Hubbard, C. Peter Wagner, and Carl George.

The Institute hosted seminars, and created the radio program The Pastor's Update and Today's Christian. The partnership ended in 1992, prior to the Fuller Evangelistic Association's closing. During that time, ownership of many of FEA's programs transferred to Fuller Theological Seminary and incorporated into the Individualized Learning Program.

#### **Scope and Content**

The Charles E. Fuller Institute of Evangelism and Church Growth Collection, 1969-1996 contains records related to the joint venture between Fuller Theological Seminary and the Fuller Evangelistic Association. The collection primarily contains annual board meeting minutes from the files of President David Allan Hubbard. It also contains files from the Fuller Theological Seminary Provost's office. Records include the formal transfer of ownership of *Today's Christian* and the *Pastor's Update* to Fuller Theological Seminary.

The collection is organized physically according to the arrangement received when transferred to the FTS Archives. Descriptions also follow the original descriptions on the received file folders. In many cases, the original colored files are still used. The color blue indicates the Presidential Files; the color yellow indicates a Provost file. Researchers will note many original file folders labeled "Box 18" and "Box 19."
