- 1. Collection name: Adolph Sutro Collection, Drawer numbers 1-42
- 2. Contents: Correspondence, deeds, ephemeral materials, pamphlets, Printed materials, receipts, typescripts, voucher, etc.
- 3. Biography: Adolph Sutro was born in Aix-la-Chapelle, Germany in 1830, and came to San Francisco in 1851. He ran a tobacco store until 1860, when he went to Nevada attracted by the silver mining. He Conceived the idea of a tunnel under the Comstock Lode which would Drain the mines and prevent them from flooding. After overcoming The opposition of the "Bank Ring" to his project, he sold out of the Completed tunnel in 1879. He began to buy books for the creation of a Large research library in the 1880s, eventually accumulating as many As 250,000 volumes. He next invested in San Francisco property, Creating the Cliff House, a popular hotel and restaurant, and Sutro Baths with its salt water swimming pools. He was elected mayor of San Francisco on the Populist ticket in 1894. He died in 1898. In 1906, the San Francisco earthquake and fire destroyed perhaps one-Half of Sutro's book collection. In 1917, the remainder of the Collection was given to the California State Library to form the core Collection of its Sutro Library branch.
