Folder 1	Review of Irving Stone's biography of Jack London, <i>Sailor on Horseback</i> , in <i>The Coast</i> , October, 1938, page 47. Note that bottom of middle column is cut out. Notation on original folder indicates this is "the book that got Barry started."
Folder 2	Letter from Yoshimatsu Nakata "to whom it may concern," dated July 19, 1939, Honolulu, Hawaii, giving his permission to publish any material written by Barry Fox [Stevens].
Folder 3	List by Barry Fox [Stevens], with attached copies (very faint) of images of Nakata, Jack London, and others.
Folder 4	Draft of <i>A Hero to His Valet</i> , by Yoshimatsu Nakata, transcribed by Barry [Fox] Stevens. Margin notes by Barry Fox [Stevens], late 1930s, Oahu, Hawaii.
