Scope and Content: The collection consists of papers, newspaper clippings, and audio tapes of public meetings, concerning the impacts of growth in the City of Concord and neighboring communities. The material was compiled by Marcus O'Connell, a Concord resident, civic watchdog and environmental activist. After O'Connell's death in 2003, his papers were donated to the Concord Historical Society. The Concord Historical Society in turn donated the collection to the Contra Costa County Historical Society in 2005. Born in Montana, Marcus O'Connell moved to San Francisco in the 1960s and then moved to Concord in 1994. He unsuccessfully ran for Concord City Council in 2000.
