**Abstract:** *Screaming Queens: The Riot at Compton's Cafeteria* is a documentary film directed by Victor Silverman and Susan Stryker. The collection contains production materials from the film, as well as full recordings of the oral histories which are excerpted in the film. These include interviews with Tenderloin residents and other people familiar with the Compton's riots, including Elliott Blackstone, Felicia Elizondo, Aleshia Brevard, Amanda St. Jaymes, Regina Elizabeth McQuade and Ed Hansen.

**Processing Information:**

Finding Aid created by Isaac Fellman in 2019, with updates by Sy Auerbach and Isaac Fellman in 2022.

This finding aid uses terminology for LGBTQ people that was in current use at the time of its creation. Descriptive language for queer identities evolves quickly and some of these terms may now be dated or even offensive. Finding aids are themselves historical documents; they reflect the moment in which they were written and often reflect the terms that subjects used for themselves. **Biographical/Organizational History Note:** *Screaming Queens: The Riot at Compton's Cafeteria* is a documentary film directed by Victor Silverman and Susan Stryker. The film tells the story of the 1966 riot at Compton's Cafeteria, a local all-night diner frequented by the queer community in the Tenderloin, and particularly by transgender women.

**Scope and Content:** The collection contains production materials from the film, as well as full recordings of the oral histories which are excerpted in the film. These include interviews with Tenderloin residents and other people familiar with the Compton's riots, including Elliott Blackstone, Felicia Elizondo, Aleshia Brevard, Amanda St. Jaymes, Regina Elizabeth McQuade and Ed Hansen. Other audiovisual materials include the rough and final cuts of the film in various formats, master and VHS copies of the trailer, an audiocassette of the Pacifica Radio show "Cops and Robbers II: Transsexuals and the Police," (4/10/1968), as well as two VHS copies of documentaries on San Francisco, *SF in the 60s* and *Gay San Francisco*.

The manuscripts and audiovisual collections contain production materials from *Screaming Queens*. These include the scripts, production notes, clippings, budgets, invoices, grant applications, list of cast, crew, key personnel, releases, contracts, photographs, and other production materials following the trajectory of the project from the original film proposal in 1996 through screenings in 2005.
