ADMINISTRATIVE HISTORY

The San Francisco Bay Chapter, founded in 1924, is second in membership size and longevity only to the Angeles Chapter, in Southern California. The chapter office, located in Oakland, serves members in Alameda, Contra Costa, Marin, and San Francisco Counties.

The Bay Chapter has served as a training ground for many prominent national Sierra Club leaders, including former executive director David R. Brower, and past presidents Richard M. Leonard, Francis P. Farquhar, Edgar Wayburn, and Lewis Clark (all of whose papers are found in the Sierra Club Members Papers, BANC MSS 71/295 c). Rock climbers, skiers, and hikers trained on local trips went on to spearhead the club's nationally-famous Outing Program.

In an effort to make the outdoors accessible and broaden the club's membership base, volunteers from the San Francisco Bay Chapter founded the Inner City Outings Program in 1971. Inner city youths and persons with disabilities were taken on hikes, camping, and river trips. By 1990, thirty additional chapters had formed their own ICO programs.

In recent years, the San Francisco Bay Chapter's hard-working volunteers and staff have been at the forefront of local conservation battles. Bay and wetlands preservation, open space, park creation and protection, water quality, hazardous waste, and energy policy issues continue to challenge Bay Chapter activists.

SCOPE AND CONTENT

The San Francisco Bay Chapter was formed in 1924. For many years the chapter shared office space with the club's headquarters at Mills Tower, in San Francisco. Now it maintains its own office and bookstore in Oakland.

The policy-setting body for the chapter is the Executive Committee. Reading the minutes and agendas of Executive Committee meetings, as well as the annual reports and financial records, provides a good overview of the chapter's interests and conservation efforts.

Committees and task forces focus on the governance of the chapter and its conservation concerns. Sections and groups focus on activities, arranged by interest (sections) or location (groups).

The chapter's earliest documented activities included an ambitious and apparently well-attended Local Walks program. More recent activity schedules list an impressive number of activities: river touring, car camping, rock climbing, snowshoeing, hiking, ski touring, natural science outings, bicycling, dinners, family outings, and "peakbagging," to name only a few.

The subject files are general in nature, focusing on land use planning and San Francisco Bay protection.

The papers of the conservation coordinators, Paula Carrell and David Nesmith, are more detailed and specific. They include litigation in which the San Francisco Bay Chapter has taken a leading role or filed an amicus brief. Some of the important topics include hazardous wastes; San Francisco Bay fill and wetlands protection; energy issues, such as the proposed Crockett Cogeneration Plant; water resources development (Westlands Water District); and land use (Acme Landfill and the Apperson Ridge Quarry). Dana Kokubun papers are primarily concerned with wetlands preservation litigation.

Files are arranged in the following subseries: committees, task forces, sections, groups. Each subseries is arranged alphabetically. (Executive Committee records are filed in the Operational and Financial Records, Series 1.)

The activities of the Conservation Committee, Local Walks Committee, and the Rock Climbing Section are particularly well documented.

SERIES 3: SUBJECT FILES, 1934-1982.

Cartons 8-11

Files are arranged alphabetically by subject.

Major topics are San Francisco city planning issues and the San Francisco Bay.

SERIES 4: CONSERVATION COORDINATORS RECORDS, 1932-1990.

Cartons 11-24

This series is divided into three subseries. The first is Paula Carrell's Papers, which contains subject files arranged alphabetically. Major topics include hazardous wastes, San Francisco Bay fill, and wetlands protection.

David Nesmith's Papers are also arranged alphabetically by subject. Subjects include the Acme Landfill; acreage allotments; the Apperson Ridge Quarry; the Crockett Cogeneration Project; the East Bay Municipal Utility District; the Westlands Water District; and the Westside Treatment Facility and Southwest Ocean Outfall. The final subseries, Dana Kokubun's papers, is arranged alphabetically by subject. These papers are mainly concerned with wetlands preservation topics in the San Francisco Region.
